

A period of work that can be bought back is a period during which you were gainfully employed in the public sector and during which you did not contribute to your public-sector pension plan. It can be a period of work during which you worked:

- as a casual employee, between 1 July 1973 and:
  - 31 December 1986, if you were an employee in the health and social services sector who was on a recall list,
  - 31 December 1987, if you were an employee in the health and social services sector who was not on a recall list, or an employee in the public or education sectors;
- at a research centre in the health and social services sector;
- on or before 30 June 2011 at an organization that became subject to a plan further to an order in council issued after that date;
- as a member of the Lieutenant-Governor's, a Minister's or a member of the National Assembly's staff.

You must use this form to file an application for a buy-back if you are a member of one of the following plans:

- Government and Public Employees Retirement Plan (RREGOP);
- Pension Plan of Management Personnel (PPMP);
- Retirement Plan for Senior Officials (RPSO);
- Pension Plan of Certain Teachers (PPCT);
- Pension Plan of Peace Officers in Correctional Services (PPPOCS);
- Superannuation Plan for the Members of the Sûreté du Québec (SPMSQ).
